The Affiant states that on 3-4-96 at approximately 2:30 a.m.,

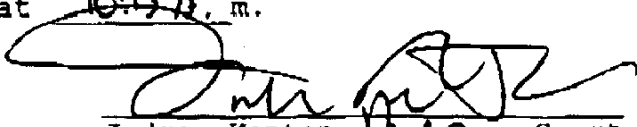
██████████ reported to him that she was forcible raped by an individual known to her while at the Drawbridge Motor Inn. Ms.

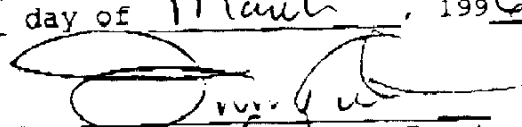
